



## Terms and Conditions of Beta Test Programme

### Programme Period

The Beta Test Programme (“Programme”) organized by Medklinn International Sdn Bhd (845537-V) (“Organizer”) will run from 1<sup>st</sup> June 2021 to 31<sup>st</sup> August 2021 (both dates inclusive) (“Programme Period”). The Programme will be held for EIGHTEEN (18) weeks as follows:

- a. Submission Period: 1<sup>st</sup> June 2021 –31<sup>st</sup> August 2021
- b. Beta Test Period: 1<sup>st</sup> July 2021 – 30<sup>th</sup> September 2021

### Beta Product

1. Product Model for this Programme: Medklinn PRO AD150DF Air+Surface Sterilization System (“Product”).
2. Warranty period: THREE (3) years from the date of purchase subject to Annual Maintenance service and [3-Year Warranty Terms and Conditions](#).
3. Installation is not included.

### Eligibility

1. Open to all businesses in Malaysia who have a physical enclosed office/shop with less than 1,500 sq ft.
2. Employees and its immediate family members of Medklinn group of companies are NOT eligible to participate in this Programme.

### Application Details

1. To participate, business owners (“Applicants”) must apply online with the Organizer at <https://my.medklinn.com/business/pro-as150df-beta-test-programme/>; Each participant can only register for one application throughout the Programme Period.
2. Application Deadline is 31<sup>st</sup> August 2021, 23:59 GMT.
3. Selected Participants (“Participants”) will receive an email with a PayPal payment link to pay for the Product.

### Participant Selection

1. The Organizer's decisions are final and binding in all matters relating to this Programme and no correspondence thereon will be entertained.
2. The Organizer will select 50 eligible applicants to participate in the Programme.
3. The organizer reserves the right to request written proof of business license and layout plan from the Participants prior to selection. The Organizer reserves the right to reject the entry for the Participant if he/she does not provide the required details upon receiving the request/notification from the Organizer within the stipulated period.
4. Upon successful selection, the Organizer will attempt to contact the Participants for company details, unit delivery and installation details.
5. Participants will be notified by Medklinn via email, phone call and/or WhatsApp message. In the event the shortlisted Participant is not reachable, or he/she does not respond to the communication, Medklinn will make two (2) further attempts to reach the Participant. In the event the Participant is still unreachable after two (2) further attempts within five (5) days from



the official email confirmation, making it impossible for the organizer to perform company identity verification, the participant shall be disqualified.

6. The Organizer reserves the right to select the next qualified Participant after TWO (2) unsuccessful attempts to contact the selected Participant.
7. The Organizer will not be held liable in the event selected Participant is not contactable.
8. Selected Participants must provide the following through email by the end of Programme period:
  - a. Company logo (Format: PNG or AI)
  - b. A Video Testimonial (Up to 60 seconds)
  - c. High resolution Photographs of the actual site with Medklinn system installed.

### Rights of the Organizer

4. The Organizer's decision is final. No further correspondence or appeal will be entertained.
5. Entries received before and/or after the Submission Period will be void. All entries become the sole property of Organizer and will not be acknowledged.

### Terms of Participation

2. Each Participant can purchase up to a maximum number of TWO (2) units of PRO AS150DF.
3. As part of the Programme, Participants must complete an online survey ("Survey") after the Beta Test Period. The Survey link will be emailed to the Participants.
4. By participating in this Programme, Participants fully and unconditionally agree to and accept the official Terms & Conditions as stated in this document and decisions of the Organizer and explicitly consents to her/his name, company name, company logo and picture being published on the Internet (website and social media site of the Organizer), and possibly also in the print media of the Organizer in the event of being successfully selected.
5. The Organizer reserves the right to approve or reject any entry submitted which are not legible, fraudulent or for any other reasons at its discretion. For the avoidance of doubt, the Organizer reserves the right, as it deems fit to determine if the supporting documents are sufficiently legible or genuine for purposes of the approval of the application.
6. The Organizer reserves the right to cancel, terminate or suspend the Programme without any prior notice. For the avoidance of doubt, any cancellation, termination or suspension by the Organizer of the Programme shall not entitle the Participant to any claim or compensation against the Organizer and its employees for any and all losses or damages suffered or incurred by the Participant as a direct or an indirect result of the act of cancellation, termination or suspension thereof.
